

# **MEMBERSHIP TERMS & CONDITIONS**

#### **ADMINISTRATION**

- Appropriate covered footwear and shirt must be worn and towels must be used at all times during gym session.
- · Memberships are not refundable or transferable.
- · All weights and equipment must be put back after use.
- Gym members are responsible for their membership cards. Shared membership cards with a non-member will result in forfeiture of membership immediately.
- Photo ID cards (Student card or driver's license) must be carried and shown upon request.
- Each member must respect other gym users and behave in an appropriate manner.
- Bodyworks Fitness staff reserve the right to withdraw members not complying with the terms and conditions of the membership.
- Gym members must report lost or stolen membership cards. All re-issued membership cards come at a fee of \$20.
- If you allow a non-member into the gym outside staffed hours you will lose your bond payment and your membership will be terminated immediately.

#### **ACKNOWLEDGMENT OF RISKS, INJURY & OBLIGATIONS**

I acknowledge that the activity I am to undertake is a dangerous activity and that by participating in it I am exposed to certain risks.

I acknowledge and understand that by participating in such activities;

- I may be injured, physically or mentally, or may die;
- · My personal property may be lost or damaged;
- · I may cause injury to other persons or damage their property;
- Other persons participating in such activity may cause me injury or may damage my property;
- The conditions in which the activity is conducted may vary without warning;
- There may be no or inadequate facilities for treatment or transport if I am injured.
- I assume the risk of and the responsibility for any injury, death or property damage resulting from my participation in activity.

#### **RELEASE AND INDEMNITY**

I participate in the activity at my sole risk and responsibility.

I release, Indemnity and hold harmless Bodyworks Fitness 24/7 from and against all and any actions or claims which may be made by me or by other parties for or in respect of or arising out of any injury, loss, damage or death caused to me or my property whether by negligence or breach of contract.

## **TERM MEMBERSHIPS**

Term memberships of 12 or 24 months that have a minimum fixed term. After the specified term has been reached you can cancel your payments at anytime. If you don't cancel your payments they will continue weekly until you do so.

### **DIRECT DEBIT MEMBERSHIPS**

Direct Debit is an automatic deduction from a bank account or credit card (Visa, BankCard or MasterCard only) through Debit Success Billing Service. Weekly no contract payments are an ongoing membership and deductions will be maintained unless the member provides authorisation to cancel the direct debit.

Term memberships of 12 months, have a minimum fixed term or otherwise a \$150 fee to break the contract.

Term memberships of 24 months, have a minimum fixed term or otherwise a \$300 fee to break the contract.

If a customer fails their payment via Direct debit system a failed payment fee will be charged to the customer of \$10.00.
